Your Directors take pleasure in presenting the Twenty Fourth Annual Report of the Company for the Financial Year 2022-23 consisting of Balance Sheet and Profit & Loss Account and the Auditors Report thereon.

**1. FINANCIAL HIGHLIGHTS**

Standalone Revenue from Operations comprising of Sales and Services of Information & Communications Technology (ICT) including other Income for the Financial Year ended 31<sup>st</sup> March, 2023 is INR.2,100.30 million as compared with INR.2,008.26 million during the previous year. The Company has since obtained written consent letter and certificate from the Auditor under Section 139 and Section 141 of the Act.

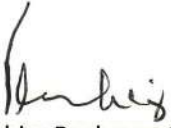

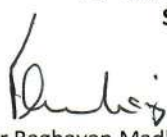

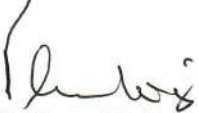

**Independent Auditor's Report**

**To the Members of SRIT India Private Limited**

**Opinion**

We have audited the accompanying standalone financial statements of SRIT India Private Limited ("the Company"), which comprise the balance sheet as at March 31, 2023, the statement of profit and loss and the Cash Flow Statement of the Company for the year ended March 31, 2023 and a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Companies Act, 2013 ("the Act") in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2023, and its profit and cash flows for the year ended on that date.

**Basis for Opinion**

We have conducted our audit in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Companies Act, 2013. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the standalone financial statements section of our report. We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India (ICAI) together with the independence requirements that are relevant to our audit of the standalone financial statements under the provisions of the Companies Act, 2013 and the Rules there under, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence obtained is sufficient and appropriate to provide a basis for our opinion on the standalone financial statements.

**Emphasis of Matter**

Attention is drawn to note 2.43 regarding the requirement of the company to spend for the purpose of Corporate Social Responsibility (CSR) expenditure as mandated u/s 135 of the Companies Act, 2013. The company has relied upon the expert opinion obtained during the year and not provided for any unspent CSR provision as contrary to the previous year where an unspent CSR provision of 8.36 million was provided for.

Further, the attention is also drawn to note no 2.45 the company has created provision for extinguishment of liability during the year against inter corporate deposit liability.

The company has not ascertained from the suppliers and service providers as to their status as Micro or Small enterprise under the Micro and Small Enterprises Development (MSMED) Act, 2006 ("MSMED Act") and disclosures relating to Micro and Small Enterprises in the financial statements as required under section 22 of the MSMED Act and as required under Schedule III to the Act. Consequential impact, if any, on the financial statements is not ascertainable.

Our opinion is not qualified in respect of the above matters.

#### **Other Information**

The Company's board of directors is responsible for the preparation of the other information. The other information comprises the information included in the Board's Report including Annexures to Board's Report, Business Responsibility Report but does not include the standalone financial statements and our auditor's report thereon.

Our opinion on the standalone financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the standalone financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the accompanying standalone financial statements or our knowledge obtained during the course of our audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

#### **Management's responsibility for the standalone financial statements**

**1. Significant accounting policies**

**1.1 Background**

SRIT India Private Limited ("the Company") was incorporated on 9<sup>th</sup> September 1999 as a private limited company under the Companies Act having its registered office in SRIT House, #113/1B, ITPL Main Road,, Kundalahalli, Bangalore, Karnataka, India, 560037. The Company is in the business of providing software services.

**1.2 Significant Accounting Policies**

The significant accounting policies have been predominantly presented below in the order of the Accounting Standards notified under the Companies (Accounting Standards) Rules, 2014 (as amended), accordingly, the company has complied with all the applicable Accounting Standards.

**1.3 Basis of preparation of financial statements**

These financial statements have been prepared and presented under the historical cost convention on the accrual basis of accounting and comply with the mandatory Accounting Standards prescribed in the Companies (Accounting Standards) Rules, 2014, issued by the Central Government, the relevant provisions of the Act and other accounting principles generally accepted in India, to the extent applicable. The financial statements are presented in Indian rupees ("Rs.") and the figures in the financial statements are rounded off to the nearest multiples of millions. The Company generally follows mercantile system of accounting and recognizes significant items of income and expenditure on accrual basis.

**1.4 Use of estimates**

The preparation of financial statements in accordance with generally accepted accounting principles in India requires management to make judgments, estimates and assumptions that affect the application of accounting policies and reported amounts of assets, liabilities, income and expenses and the disclosure of contingent liabilities on the date of the financial statements. The estimates and assumptions used in the accompanying financial statements are based upon management's evaluation of the relevant facts and circumstances as of the date of the financial statements. Actual results could differ from those estimates and underlying assumptions are reviewed on an ongoing basis. Any revision to accounting estimates is recognized prospectively in current and future periods.

Significant estimates used by the management in the preparation of these financial statements include, work in progress, provision for bad and doubtful debts, estimates of the useful life of the fixed assets.

**1.5 Inventories**

Inventories are valued at the lower of cost (on FIFO / weighted average basis) and the net realisable value after providing for obsolescence and other losses, where considered necessary. Cost includes all charges in bringing the goods to the point of sale, including octroi and other levies, transit insurance and receiving charges. Work-in-progress and finished goods include appropriate proportion of overheads.



**1.6 Cash Flow Statement**

Cash flow is reported using the indirect method, whereby net profit/loss before tax is adjusted for the effects of transaction of a non-cash nature and any deferrals or accruals of past or future cash receipts or payments. The cash flow comprises regular revenue generating, investing and financing activities of the company. Cash and cash equivalents in the balance sheet comprise of cash at bank and in hand and short term, highly liquid investments with an original maturity of three months or less, that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value.

**1.7 Revenue recognition**

Revenues from service contracts are recognized on the proportionate completion method where no significant uncertainty exists regarding the amount of consideration that will be derived on completion of the contract.

The company derives its revenue primarily from software services. Revenue from software development on time-and-material basis is recognized as the related services are rendered.

Revenue from software consultancy and support services are recognised as per the terms and conditions of agreement and when services are rendered and related costs are incurred.

Interest income on deposits is recognised on time proportionate basis considering the amount outstanding and rates applicable

**1.8 Property, Plant and Equipment**

Property, Plant and Equipment are carried at the cost of acquisition or construction less accumulated depreciation. The cost of Property, Plant and Equipment includes freight, duties, taxes and incidental expenses related to the acquisition and installation of Property, Plant and Equipment.

The cost of Property, Plant and Equipment not ready for use before the balance sheet date is disclosed as capital work-in-progress. Advance paid towards their intended acquisition of Property, Plant and Equipment outstanding as of each balance sheet date is disclosed under long-term loans and advances.

Property, Plant and Equipment are tested for impairment and assets which are not expected to generate any future cash flows are stated at their Net Realizable Value.

**1.9 Intangible Assets**

Research costs are expensed as Incurred. Development costs that are directly attributable to Intangible assets are capitalised when the following criteria are met:

- It is technically feasible to complete the intangible asset so that it will be available for use
- Management intends to complete the Intangible asset and use or sell it
- It can be demonstrated how the Intangible asset will generate probable future economic benefits
- Adequate technical, financial and other resources to complete the development and to use or sell the intangible asset are available; and
- The expenditure attributable to the intangible assets during its development can be reliably measured.



Directly attributable costs that are capitalized as part of the intangible assets Includes employee costs and an appropriate portion of relevant overheads.

Capitalised development costs are recorded as intangible assets and amortised from the point at which the asset is available for use.

Subsequent expenditure is capitalized only when it increases the future economic benefits embodied in the specific asset to which it relates

#### **1.10 Depreciation**

Depreciation is provided on written down value method over the useful life of Property, Plant and Equipment. Depreciation on Property, Plant and Equipment has been provided at the rate prescribed in Schedule II of the Act as the management expects these rates to reflect the useful life of these Property, Plant and Equipment.

Depreciation on Intangible assets is computed at the rates based on the estimated useful lives of the asset.

Depreciation is charged on a proportionate basis from/up to the date the assets are purchases/sold during the period.

The difference between the depreciation for the year on revalued Intangible asset and Depreciation calculated on the original cost is recouped from the fixed assets revaluation reserve

#### **1.11 Foreign Currency Transactions**

All transactions in foreign currency are recorded on the basis of the exchange rate prevailing as at the date of transaction. The difference, if any, on actual payment / realization is dealt in the profit & loss account. Monetary assets and liabilities denominated in foreign currency are restated at rates prevailing at the year-end. The net loss or gain arising out of such conversion is dealt in the profit & loss account.

#### **1.12 Investments**

Long-term investments (excluding investment properties), are carried individually at cost less provision for diminution, other than temporary, in the value of such investments. Current investments are carried Individually, at the lower of cost and fair value. Cost of investments Include acquisition charges such as brokerage, fees and duties.

Investment properties are carried individually at cost less accumulated depreciation and impairment, if any. Investment properties are capitalised and depreciated (where applicable) in accordance with the policy stated for Tangible Assets. Impairment of Investment property is determined in accordance with the policy stated for Impairment of Assets.

#### **1.13 Employee Benefits**

Employee benefits include provident fund, superannuation fund, gratuity fund, compensated absences, long service awards and post- employment medical benefits.

Defined contribution plans

The Company's contribution to provident fund and superannuation fund are considered as defined contribution plans and are charged as an expense as they fall due based on the amount of contribution required to be made.



**Defined benefit plans**

For defined benefit plans in the form of gratuity fund and post-employment medical benefits, the cost of providing benefits is determined using the Projected Unit Credit method, with actuarial valuations being carried out at each Balance Sheet date. Actuarial gains and losses are recognised in the Statement of Profit and Loss in the period in which they occur. Past service cost is recognised immediately to the extent that the benefits are already vested and otherwise is amortised on a straight-line basis over the average period until the benefits become vested. The retirement benefit obligation recognised in the balance sheet represents the present value of the defined benefit obligation as adjusted for unrecognised past service cost, as reduced by the fair value of scheme assets. Any asset resulting from this calculation is limited to past service cost, plus the present value of available refunds and reductions in future contributions to the schemes.

**1.14 Borrowing cost**

Borrowing costs include interest, amortization of ancillary costs incurred and exchange differences arising from foreign currency borrowings to the extent they are regarded as an adjustment to the Interest cost. Costs in connection with the borrowing of funds to the extent not directly related to the acquisition of qualifying assets are charged to the Statement of Profit and Loss over the tenure of the loan. Borrowing costs, allocated to and utilised for qualifying assets, pertaining to the period from commencement of activities relating to construction/development of the qualifying asset upto the date of capitalisation of such asset is added to the cost of the assets. Capitalisation of borrowing costs is suspended and charged to the Statement of Profit and Loss during extended periods when active development activity on the qualifying assets is Interrupted.

**1.15 Accounting for taxes on Income:**

Current tax on income for the period is determined on the basis of taxable income and tax credits computed in accordance with the provisions of the Income Tax Act, 1961 and based on the expected outcome of assessment/appeals.

Deferred tax is recognized on timing differences between the accounting income and the taxable income for the year, and quantified using the tax rates and laws enacted or substantively enacted as on the Balance Sheet date.

Deferred tax assets are recognized only to the extent there is reasonable certainty that the assets can be realized in the future; however, where there is unabsorbed depreciation or carried forward business loss under taxation laws, deferred tax assets are recognized only if there is a virtual certainty of realization of such assets.

Deferred tax assets and deferred tax liabilities are offset if a legally enforceable right exist to set off current tax assets against current tax liabilities and deferred tax assets/deferred tax liabilities relate to some taxable entity and same taxation authority.



**1.16 Leases**

Where the Company as a lessor leases assets under finance leases, such amounts are recognised as receivables at an amount equal to the net investment in the lease and the finance income is recognised based on a constant rate of return on the outstanding net investment.

Assets leased by the Company in its capacity as lessee where substantially all the risks and rewards of ownership vest in the Company are classified as finance leases. Such leases are capitalised at the inception of the lease at the lower of the fair value and the present value of the minimum lease payments and a liability is created for an equivalent amount. Each lease rental paid is allocated between the liability and the interest cost so as to obtain a constant periodic rate of interest on the outstanding liability for each year.

Lease arrangements where the risks and rewards incidental to ownership of an asset substantially vest with the lessor are recognised as operating leases. Lease rentals under operating leases are recognised in the Statement of Profit and Loss on a straight-line basis.

**1.17 Provisions**

A provision is recognized if, as a result of a past event, the Company has a present obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation. Provisions are recognized at the best estimate of the expenditure required to settle the present obligation at the balance sheet date. The provisions are measured on an undiscounted basis.

Provision in respect of loss contingencies relating to claims, litigation, assessment, fines, penalties, etc. are recognized when it is probable that a liability has been incurred, and the amount can be estimated reliably.

**1.18 Contingent liabilities and contingent assets**

A contingent liability exists when there is a possible but not probable obligation, or a present obligation that may, but probably will not, require an outflow of resources, or a present obligation whose amount cannot be estimated reliably. Contingent liabilities do not warrant provisions, but are disclosed unless the possibility of outflow of resources is remote. Contingent assets are neither recognized nor disclosed in the financial statements. However, contingent assets are assessed continually and if it is virtually certain that an inflow of economic benefits will arise, the asset and related income are recognized in the period in which the change occurs.



**1.19 Impairment of assets**

The Company periodically assesses whether there is any indication that an asset or a group of assets comprising a cash generating unit may be impaired. If any such indication exists, the Company estimates the recoverable amount of the asset. For an asset or group of assets that does not generate largely independent cash inflows, the recoverable amount is determined for the cash-generating unit to which the asset belongs. If such recoverable amount of the asset or the recoverable amount of the cash generating unit to which the asset belongs is less than its carrying amount, the carrying amount is reduced to its recoverable amount. The reduction is treated as an impairment loss and is recognized in the statement of profit and loss. If at the balance sheet date there is an indication that a previously assessed impairment loss no longer exists, the recoverable amount is reassessed and the asset is reflected at the recoverable amount subject to a maximum of depreciable historical cost.

**1.20 Earnings per share ('EPS')**

The basic earnings/ (loss) per share is computed by dividing the net profit / loss attributable to equity shareholders for the period by the weighted average number of equity shares outstanding during the periods.

**1.21 Cash and cash equivalents**

Cash and cash equivalents comprise cash in hand and balance in bank in current accounts and deposit accounts.

**1.22 Key financial ratios**

In accordance with the amended Schedule III of Companies Act, 2013, the Company is required to give details of significant changes (change of 25% or more as compared to the immediately previous financial year) in key sector-specific financial ratios.
